All the general public/stakeholders of the Panaji city/villages in Tiswadi taluka are hereby informed that the Government vide its notification No.26/04/05/2024-RD/01 dated 01-Jan-2026, has completed the major ground truthing work related to the NAKSHA Pilot Project in Panaji ULB and peri urban areas. Accordingly now as per clause (6) for the purposes of determining the right, title and interest of individuals and bodies in respect of lands under survey, the Inquiry Officer shall hold an enquiry under Section 14 and Section 85 of the Goa Land Revenue Code 1968 and consider suggestions/objections received under sub-rule (2) of rule 5. Thereafter in accordance with the decision of the Inquiry Officer or, where an appeal is filed or a civil suit instituted, in accordance with the final order passed in appeal or civil suit, the draft UrPro (Urban Property Card) shall be prepared. The Inquiry process is scheduled to be held at the Office of Inspector of Survey & Land Records, Panaji. Accordingly general public are directed to appear before the concerned Inspector of Survey & Land Records along with the documents related to title of the property on the below mentioned dates:
